- The financial upgradation under the MACP Scheme has been granted as per provisions as contained in the Government of India, Ministry of Personnel, Public Grievances and Pension (Department of Personnel and Training) O.M. No. 35034/3/2008-Estt dated 19 th May, 2009 and O.M. 35034/3/2015-Estt.(D) dated 22.10.2019.
- 3. Fixation of pay on grant of financial upgradation under MACPs shall be made as per Rule 13 of CCS (RP) Rules, 2016 issued vide Department of Expenditure notification dated 25<sup>th</sup> July, 2016, and in terms of provisions contained in DoP&T OM 13/02/2017-Estt. (Pay-1) dated 27.07.2017. With regard to fixation of his pay on grant of promotion/ financial upgradation under MACP Scheme, a Government servant has an option under FR 22(1)(a)(1) to get his pay fixed in the higher post/Pay level either from the date of his promotion/upgradation

or from the date of his next increment viz.1st July or 1st January, subject to provisions in the Scheme.

The date of eligibility of financial upgradation under MACP Scheme in respect of the above official is to be scrutinized by the concerned controlling officers from the Service Book of the concerned officials, and if any discrepancy is found thereon, the same should be brought to the notice of this office within 15 days of receipt of the order.
