2. The financial upgradation under MACP Scheme has been granted as per provisions as contained in Government of India, Ministry of Personnel, Public Grievances and Pension (Department of Personnel and

Training) O.M. No. 35034/3/2008-Estt dated 19th May, 2009
and O.M. 35034/3/2015-Estt.(D) dated 22.10.2019.

3. Fixation of pay on grant of financial upgradation under MACPs shall be made as per Rule 13 of CCS (RP) Rules, 2016 issued vide Department of Expenditure notification dated 25th July, 2016, and in terms of provisions contained in DoP&T OM 13/02/2017-Estt. (Pay-1) dated 27.07.2017. With regard to fixation of his pay on grant of promotion/financial upgradation under MACP Scheme, a Government servant has an option under FR 22(1)(a)(1) to get his pay fixed in the higher post/Pay level either from the date of his promotion/upgradation or from the date of his next increment viz. 1st July or 1st January, subject to provisions in the Scheme.
