2. The monetary benefits shall be payable to the officials from the date of assumption of the charge in the promoted post.

3. The above official may exercise the option for fixation of pay within a month in accordance with relevant rules, wherever found necessary.

4. The above officials are allowed to join duty on as -is-where-is basis. Their final place of posting as per the organizational requirement will be decided and communicated in due course. Until such final orders are issued, these officials shall continue to discharge their duties at their current location.

5. As per Para 6 of CMPF (Employees' Recruitment) Rules, 2024, there shall be a mandatory training of at least two weeks' duration in all cases of promotion from one Group to another Group. Since the promotion of Social Security Assistant to the post of Senior Social Security Assistant is from Group 'C' to Group 'B', there shall be a probation of two years.
